### How We Use Cookies

MGT uses cookies, tags, pixels and similar technologies to enhance your experience on the internet. These technologies allow us to recognize your preference information, keep track of the choices you make concerning the e-mails you wish to receive, and to facilitate effective Web site administration. You may elect to refuse cookies through your web browsers. Please refer to your browser's Help instructions to learn more about cookies.

MGT may use one or more of the following types of cookies:

### i. <u>Strictly Necessary cookies</u>

Necessary cookies are required for the operation of the Website. These cookies are essential to make the Website work correctly. They include cookies that remember previous actions (e.g., entered text) when navigating back to a page in the same session. These cookies do not identify you as an individual. If you do not accept necessary cookies, it may affect the performance of the Website or parts of it.

### ii. <u>Functionality cookies</u>

Functionality cookies are used to recognize you when you return to the Website and to remember the choices you made to enable MGT to personalize its content to you. The information the functionality cookies collect may include personally identifiable information that you have disclosed. If you do not accept functionality cookies, it may affect the performance and functionality of the Website and may restrict access to its content.

### iii. <u>Performance/Analytical cookies</u>

Analytical/performance cookies allow MGT to recognize and count the number of visitors and help MGT understand how visitors interact with the Website by providing information about, among others, the areas visited, the time spent on the Website and any issues encountered. This helps MGT to improve the way the Website works. Performance cookies do not identify you as an individual. All data is collected and aggregated anonymously.

### iv. <u>Targeting/Advertising cookies</u>

Advertising/targeting cookies record your visit to the Website, the pages you have visited and the links you have followed. MGT will use this information to make the Website and the advertising displayed on these sites more relevant to you and your interests. The advertising cookies may be used to deliver targeted advertising and to help MGT measure the effectiveness of advertising campaigns. MGT may also share this information with third parties (including advertisers) for this purpose. Most advertising cookies track users via their IP address and may collect personal data.

### **Retention Period**

We will retain your Personal Information consistent with MGT's then-current data retention policy(s) and only for as long as needed or permitted in light of the purpose(s) for which it was obtained and consistent with applicable law. The criteria used to determine our retention periods include: (i) the length of time we have an ongoing relationship with you and provide the Service to you; (ii) whether there is a legal obligation to which we are subject; or (iii) whether retention is legally advisable (for example, in regard to applicable statutes of limitations, litigation or regulatory investigations). Notwithstanding the above, MGT shall not keep your personal data longer than necessary for the purposes for which they were collected or as required by applicable law.

### Further Rights for Persons or Information Covered By GDPR

If you are a covered individual under the General Data Protection Regulation ("GDPR") or the UK's Data Protection Act, you have legal rights in relation to the Personal Information that we hold about you. These rights include:

- Right to be informed. You have the right to request information about how we process your personal information.

- Right of access. You have the right to request that we confirm whether we process your personal information. You can also request to access your personal information.

- Right to rectification and erasure. If we hold inaccurate or incomplete personal information, you can ask us to rectify or complete that Information. You can also ask us to erase your personal information. This right is not absolute and only applies in certain circumstances.

- Right to restrict processing. You can ask us to restrict the processing of your personal information (or to suppress it) for a certain period of time. This right is not absolute and only applies in certain circumstances.

- Right of data portability. You can ask us to move, copy or transfer your personal information back to you or to another person under certain circumstances. This right only applies: (a) to personal information you have provided to us as a Data Controller; (b) where the processing is based on your consent or for the performance of a contract; and (c) when processing is carried out by automated means.

- Right to object. You can ask us at any time to stop processing your personal information for marketing purposes. Where there are legitimate grounds to do so, you can also object to us Processing your personal information on the basis of our legitimate interests and in certain other situations.

- Right to withdraw consent. Where we are processing your personal information based on your consent, you can withdraw that consent at any time.

- Rights in relation to automated decision-making and profiling. You have the right to: (a) ensure that any significant decisions affecting you are not made purely by automated means based on an online profile or other information (i.e. a person is involved in the decision-making), and (b) that you can express your views and to challenge the decision.

- In order to enable us to provide the Service.
